Würth Elektronik cannot insure the reliability of these components while being used with other products.</div> <div>Product Specific:</div> <div>Soldering:</div> <div><ul style="list-style-type: none">The solder profile must comply with the Würth Elektronik technical soldering specification, otherwise this will void the warranty.Other soldering methods are not verified and have to be validated by the customer at his own risk.</div> <div>Cleaning and Washing:</div> <div><ul style="list-style-type: none">Parts are not constructed for washing, so washing can cause malfunction afterwards.Cleaning agent that are used to clean the customer applications might damage or change the characteristics of the component, body, pins and termination.Please do not submerge our washable products into water or cleaning agents or put them in locations exposed to water completely.When cleaning by hand (brushing), please do not use excessive force on our connectors to avoid malfunction afterwards, because customer could deform function relevant areas.We recommended a solution without organic acid (preserve the plating against corrosion) volatile, without residues and compatible with the plastic.We recommend to perform tests and to let a part in immersion in the solution 8 to 12 hours and see if there is a degradation.</div> <div>Storage Conditions:</div> <div><ul style="list-style-type: none">The Connectors are considered MSL1 into closed original packaging and are not subject to storage time limits regarding the moisture sensivity but all products shall be used before the end of the period of 12 months based on the products date code, if not 100% solderability can't be warranted.</div> <div>Handling:</div> <div><ul style="list-style-type: none">Do not repeatedly operate the connector with excessive force.
