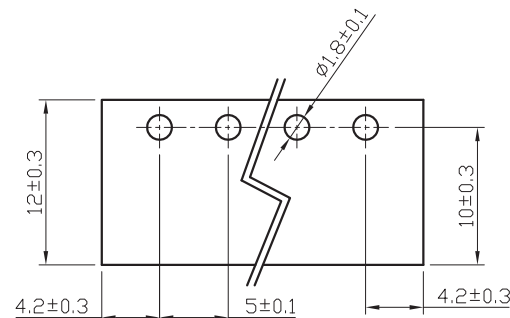
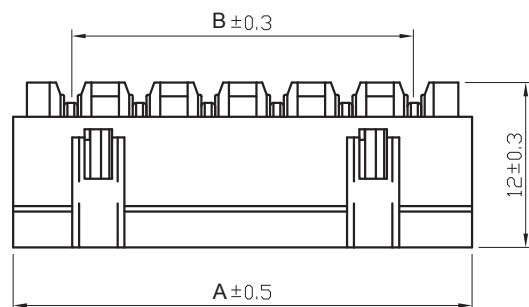
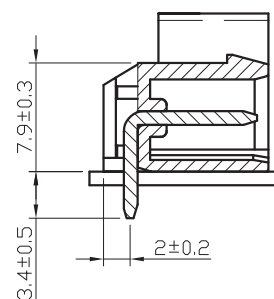
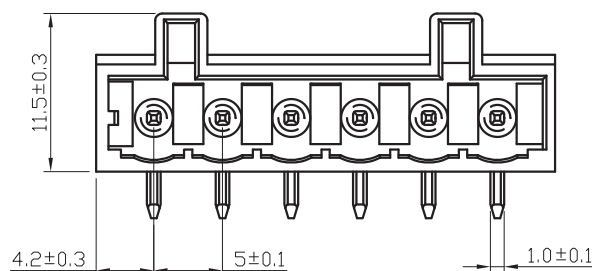




RECOMMENDED PCB LAYOUT - COMPONENT VIEW

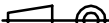
